



# Lebanon Parks and Recreation Rules and Regulations

Listed are rules and regulations for the City of Lebanon Parks and Recreation Department, grounds, and facilities. If you do not find answers to your questions under the following outline, please call the Park Office at 765-482-8860.

## Memorial Park and Abner Longley Park

- Park Hours- 6:00am-11:00pm.
- Smoking is prohibited including vapor pens and e-cigarettes.
- Possession of alcohol is not permitted in the park without permit from the Park Board.
- Vehicles are not permitted on the grass.
- No fireworks or open fires permitted.
- Dogs must be on a leash at all times, please pick up animal waste.
- No marketing, vending, sales or using city property to make profit without written permission.
- \$50.00 minimum fine for littering.
- No firearms permitted.
- No metal detectors.

## Seashore Waterpark

- Anyone who has or had diarrhea in the last (2) weeks shall not use the pool.
- Anyone who has an area of exposed subepidermal tissue, open blisters, cuts, etc., is advised not to use the pool.
- All person shall take cleansing shower before using the pool. A bather leaving the pool to use the restroom shall take another cleansing shower before returning to the pool enclosure.
- Spitting, spouting of water, blowing the nose, and similar behavior in the pool is prohibited.
- No running or rough play is permitted in the pool, on the runways, on floats, on platforms, in dressing rooms, or in the showers.
- Street clothes are not allowed in the pool.
- All diapers-ages children shall use plastic pants with tight fitting elastic at the legs or waist, or swim diapers.
- Do not change diapers at poolside.

## Abner Longley Splash Pad

- Hours- 10:00am-8:00pm

- No lifeguard on duty- Play at your own risk.
- No pets allowed in splash pad area.
- Children must always have adult supervision.
- Children who are not toilet trained must wear swim diapers (regular diaper changing should occur).
- Persons, especially children, who are experiencing diarrhea must not use the splash pad.
- The following activities and items are not permitted in the splash pad area;
  - Climbing, sitting, and playing on splash pad apparatus.
  - Drinking splash pad water, spitting and spouting of water from the mouth.
  - Running, rough play, and profanity.
  - Inflatable pool toys, athletic and other recreation equipment.
  - Food, candy, gum, beverages, and glass containers.
  - Soaps, detergents, and shampoos.
  - Animals except service animals.
  - Changing diapers.
  - Radios and other acoustical devices.
  - Skateboards, skates, razors, rollerblades, scooters, bicycles, and similar recreation equipment.
  - Smoking including vapes and e-cigarettes.
- Proper swim attire is required.
- Shelter and their picnic tables are available for general use unless reserved. Groups with reservations have priority use of shelter and their picnic tables.
- At the first sign of thunder and lightning, vacate the splash pad and seek a fully enclosed shelter. Remain indoors until at least 30 minutes after the last sign of thunder or lightning.

### **Conservation Park Pond**

- Hours- Friday, Saturday, & Sunday 8:00am-6:00pm
- Enter at your own risk.
- Smoking is prohibited including vapor pens and e-cigarettes.
- Possession of alcohol or firearms is not allowed.
- Vehicular traffic is not allowed.
- No fireworks or open fires allowed.
- Dogs must always be on a leash. Please pick up animal waste.
- \$50.00 minimum fine for littering.
- No marketing, vending, sales, or using city property to make profit without written permission.
- No metal detectors.
- Fishing is catch and release only. Must have IN fishing license.
- No boats or flotation devices allowed.
- Under 16 must be accompanied by an adult.
- Failure to adhere to these rules will result in exclusion from the Park System.

## Dog Park

- All dogs must be licensed members of the Lebanon Dog Park and be current on all required vaccinations.
- Pick up your dog's waste and dispose of it in the receptacles provided.
- Dog park opens at sunrise and closes at sunset daily.
- Handlers must remain in the fenced area with their dogs. Owners must always be in view of their dog and have voice control.
- Dogs greater than 35 pounds must use the large dog area.
- Discourage digging, if your dog digs a hole, fill it in.
- No more than three dogs per handler permitted at one time.
- Aggressive dogs are not permitted. Dogs must be leashed and removed at the first sign of aggression.
- Owners must always have leash in hand.
- Dog handlers must be at least 16 years of age. Keep small children under strict supervision while in the off-leash area. Spectators should remain outside the fenced area.
- No dogs in heat. Closely monitor un-neutered males.
- Please do not bring sick dogs or puppies under the ages of 4 months to the dog park.
- Leashed dog while walking to and from the off-leash area.
- No food or treats are allowed inside park.
- All Lebanon Parks are smoke-free.

**\*\* If there is an incident, exchange contact information and leave the dog park. You are fully responsible for any injury or damaged caused by your dog. Report all incidents to the Lebanon Parks and Recreation Department (765)-482-8860. In case of an emergency or injury, please call 911 immediately. \*\***

## Hot Pond

- Park hours dawn to dusk.
- Smoking is prohibited including vapor pens and e-cigarettes.
- Possession of alcohol or firearms is not allowed.
- Vehicular traffic is not allowed.
- No fireworks or open fires allowed.
- Dogs must always be on a leash. Please pick up animal waste.
- \$50.00 minimum fine for littering.
- No marketing, vending, sales, or using city property to make profit without written permission.
- No metal detectors.
- Fishing is catch and release only. Must have IN fishing license.
- No wading or swimming allowed.
- No boats or flotation devices allowed.
